The background check is based on a digital fingerprint scan.

At the time of printing this guidebook, the cost of the background check is a **\$47 fee**.

The Recovery Fund Fee

The **Recovery Fund** is a reserve created by the state of Alabama to pay actual or compensatory damages (not including interest and court costs) to aggrieved members of the public who were harmed as a result of actions of real estate licensees that violated Alabama real estate license law.

The Recovery Fund is formally referred to as the **Real Estate**Commission Revenue Fund and the Real Estate Commission

Proportionate Fund, but most people just refer to it as

The Recovery Fund.

Is there an exemption to the Recovery Fund fee?

If a licensee decides to apply for an inactive license, he is exempt from paying the initial Recovery Fund fee of \$30.

However, if and when he decides to **switch his license to active status**, he must then pay the \$30 fee to the Commission, along with all other appropriate documentation and fees.

Research & Education Fee for ACRE

The Research & Education fee supports the Alabama Center for Real Estate (ACRE), a research and education facility that supports Alabama's real estate professionals by providing relevant resources in research, education and outreach.

This fee applies to all individual licensees. It is also referred to as the **ACRE** fee.

When is the Research & Education fee paid?

The Research & Education fee (ACRE fee) is paid when individuals apply for a temporary or original salespersons or broker license and as part of the biennial renewal fees paid by individuals.

Temporary or Original fee: \$30 fee paid when the individual applies for their license for the first time.

Recurring biannual fee: \$15.00 fee paid each time the

license is renewed.

Late License Renewal Penalty Fee

34-27-35 (g)

If the first August 31st deadline is missed, a **\$150 penalty fee** is charged to the licensee along with the usual renewal fees.


